DOCUMENTS REQUIRED FOR THE DIVORCE APPLICATION:

- If you were married within Canada, the original marriage certificate must be filed with the divorce application as per Alberta Court rules. If you do not have it, we can inform you on where to obtain it. If you married outside of Canada, the marriage certificate is not required, however, a Justice of the Court may request to see a copy.
- IF YOU HAVE CHILDREN UNDER 18: it is mandatory by the Alberta Courts to complete the Parenting After Separation (PAS) course. This is a free online course that each party is required to complete when divorcing with dependent children involved. You can complete the course online at: https://pas.albertacourts.ab.ca/products/5808-parenting-after-separation-ecourse
